The following constitutes our Privacy Policy for the collection, protection and use of the personal and private information we receive from donors and visitors to this website.

Personal Information

We collect personal information upon a visitor's request to subscribe to our newsletters and announcements. We also collect personal information about donors in connection with their donation, but will not sell, share, rent or trade this information to any third party, nor send donor mailings on behalf of other organizations.

Email Updates

We provide email updates to keep interested visitors of our website informed of developments and events related to our mission. In order to receive these updates, visitors provide their first name, last name and email address. This information will be held in complete confidence, and we will not sell, rent, trade or otherwise reveal this information to any third party. Visitors will be given the option to remove their name from our email list at the bottom of each email update.

Social Media Widgets

Our website includes Social Media features, such as the Facebook button and widgets, such as the "share this" button or interactive mini-programs that run on our site. These features may collect your IP address, which page you are visiting on our site, and may set a cookie to enable the feature to function properly. Social media features and widgets are either hosted by a third party or hosted directly on our site. Your interactions with these features are governed by the privacy policy of the company providing it.

Online Donations

Your online donations are safe and secure. We use industry-standard SSL (Secure Sockets Layer) encryption to protect the confidentiality of your personal information and the security of your transaction during transmission. Donations made through our website are in compliance with PCI data security standards. We do not store or retain your credit/debit card information after the transaction is processed.

No data transmission over the Internet, however, is 100% secure. While we strive to protect your information, we cannot ensure or warrant the security of such information. All online transactions will be confirmed by a follow-up email.

Our goal is to forge a long-term partnership with you, and we value and appreciate the trust that accompanies your online donation. If you donate online, we will never sell, rent or trade this information to a third party.

IP Addresses

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration. This is statistical data about your browsing actions and patterns and will not allow us to identify you as the user.

Cookies

We currently use cookies. A "cookie" is a parcel of text sent by a server to your web browser and then sent back unchanged by the browser each time it accesses that server.
